## **DECISION ON THE PAPERS**

This is an application by Matamata Club Incorporated for renewal of an off-licence in respect of premises situated at Waharoa Road East, Matamata known as Matamata Club Incorporated. The general nature of the business is that of a club.

This application was lodged on 10 June 2021 and was advertised in accordance with s.101 of the Act, in the Scene on 15 & 22 June 2021. No objections were received.

The days and hours of operation set out in the application are:

### **Across the Bar:**

**Monday to Sunday from 8.30 am until 9.00 pm**

### **Bottlestore:**

**Monday to Sunday from 8.30 am until 9.00 pm**

These hours are the same as the existing hours of operation and comply with the requirements of the provisional Local Alcohol Policy.

The application was referred to the Police, Medical Officer of Health and Inspector for comment. No matters in opposition have been raised in respect of the application. Accordingly the application is determined on the papers.

The applicant, in accordance with s. 212 of the Act, has named five managers with current certificates to manage the sale of alcohol from the premises.

In deciding whether to renew an off-licence the committee must have regard to the matters set out in s.105 and 131 of the Act. These are:

### **Section 105**

(a) *the object of this Act:*

A handwritten signature in blue ink, appearing to be "J. Wilcock".

- (b) *the suitability of the applicant:*
- (c) *any relevant local alcohol policy:*
- (d) *the days on which and the hours during which the applicant proposes to sell alcohol:*
- (e) *the design and layout of any proposed premises:*
- (f) *whether the applicant is engaged in, or proposes on the premises to engage in, the sale of goods other than alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which goods:*
- (g) *whether the applicant is engaged in, or proposes on the premises to engage in, the provision of services other than those directly related to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which services:*
- (h) *whether the applicant has appropriate systems, staff, and training to comply with the law:*
- (i) *any matters dealt with in any report from the Police, an inspector, or a Medical Officer of Health made under section 103*

### **Section 131**

- (a) *whether (in its opinion) the amenity and good order of the locality would be likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence:*
- (b) *any matters dealt with in any report from the Police, an inspector, or a Medical Officer of Health made by virtue of section 129:*
- (c) *the manner in which the applicant has sold (or, as the case may be, sold and supplied), displayed, advertised, or promoted alcohol.*

The object of the Act is that the sale, supply and consumption of alcohol should be undertaken safely and responsibly, and the harm caused by excessive or inappropriate consumption of alcohol should be minimised.


The Inspector has noted that he considers the applicant to be a suitable body to hold an off-licence. He has also noted that in his opinion the amenity and good order of the locality would be unlikely to be increased by more than a minor extent by the effects of a refusal to renew the licence.

I am satisfied as to those matters to which I must have regard and grant the renewal of the off-licence for a further three years.

The renewal certificate can be issued immediately.

### **Conditions**

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day:
- (b) Alcohol may be sold or supplied only to a person who—
  - (i) is a member of the club; or
  - (ii) is on the premises at the invitation of, and is accompanied by, a member of the club; or
  - (iii) is a member of some other club with which the club has an arrangement for reciprocal visiting rights for members:





- (c) Alcohol may be sold only on the following days and during the following hours:  
**Across the Bar:**  
**Monday to Sunday from 8.30 am until 9.00 pm**  
**Bottlestore:**  
**Monday to Sunday from 8.30 am until 9.00 pm**
- (d) While alcohol is being provided free as a sample drinking water to be provided free from the same location
- (e) The holder of a Manger's Certificate or a properly notified manager shall be on duty and on the premises at all times alcohol is sold. If a duty manager is not present then there must be no alcohol sales and a notice displayed advertising the public of this fact.
- (f) Manager's register (as required by s.232 of the Act) is to be maintained and available onsite.
- (g) The licensee must ensure the following are displayed:
- (i) A sign to be seen from outside the principle entrance stating the ordinary hours of business during which the premise will be open for the sale of alcohol
  - (ii) A copy of the original licence with all the conditions, just inside the principal entrance so persons entering can read it.
  - (iii) A sign in a prominent place identifying the duty manager.
- (h) There are no designations
