**DECISION ON THE PAPERS**

This is an application by Rose Allan Limited for renewal of their on-licence in respect of a premises situated at 98 Broadway, Matamata known as the Loft Hair & Co. The general nature of the business is that of a Hairdresser.

The application was filed on 9 November 2023 and was advertised in accordance with the Act, in the Scene on 14 and 21 November 2023. No public objections were received.

The days and hours of operation set out in the application are:

**Monday, Tuesday and Friday from 10.00 am until 5.00 pm**  
**Wednesday, Thursday and Saturday from 10.00 am until 8.00 pm**

The applicant has asked for a change in the hours on Saturday from those currently held, 10.00 am until 5.00 pm. The new hours being from 10.00 am until 8.00 pm. These days and hours comply with the requirements of Council's Provisional Local Alcohol Policy as it applies to this type of premises.

The application was referred to the Police, Medical Officer of Health and Inspector for comment. No matters in opposition have been raised in respect of the application. Accordingly the application is determined on the papers.

The applicant, in accordance with s.212 of the Act, has named a manager with a current certificate to manage the sale of alcohol from the premises.

In deciding whether to renew an on-licence the committee must have regard to the matters set out in s.105 and s.131 of the Act. These are:



### **Section 105**

- (a) *the object of this Act*
- (b) *the suitability of the applicant*
- (c) *any relevant local alcohol policy*
- (d) *the days on which and the hours during which the applicant proposes to sell alcohol*
- (e) *the design and layout of any proposed premises*
- (f) *whether the applicant is engaged in, or proposes on the premises to engage in, the sale of goods other than alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which goods*
- (g) *whether the applicant is engaged in, or proposes on the premises to engage in, the provision of services other than those directly related to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which services*
- (h) *whether the applicant has appropriate systems, staff, and training to comply with the law*
- (i) *any matters dealt with in any report from the Police, an inspector, or a Medical Officer of Health made under section 103*

### **Section 131**

- (a) *whether (in its opinion) the amenity and good order of the locality would be likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence*
- (b) *any matters dealt with in any report from the Police, an inspector, or a Medical Officer of Health made by virtue of section 129*
- (c) *the manner in which the applicant has sold (or, as the case may be, sold and supplied), displayed, advertised, or promoted alcohol*

The object of the Act is that the sale, supply and consumption of alcohol should be undertaken safely and responsibly, and the harm caused by excessive or inappropriate consumption of alcohol should be minimised.

The Inspector has noted that he considers the applicant, Rose Allan limited, to be suitable to hold an on-licence. He has also noted that in his opinion the amenity and good order of the locality would be unlikely to be increased by more than a minor extent by the effects of a refusal to renew the licence.

I am satisfied as to those matters to which I must have regard and grant the renewal of the on-licence for a further three years.

The renewal certificate can be issued immediately.

### **Conditions**

- a) No alcohol is to be sold on the premises on **Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.**

- b) Alcohol may be sold only on the following days and during the following hours:

**Monday, Tuesday and Friday from 10.00 am until 5.00 pm**

**Wednesday, Thursday and Saturday from 10.00 am until 8.00 pm**

- c) The licensee shall take the following steps to ensure that the provisions of the Act relating to the management of the premises are observed:
- i) All staff will be trained in their responsibilities under the Act
  - ii) Evidence of age documents will be requested from any person appearing to be under the age of 25
- d) Food must be available for consumption on the premises as follows: A range of food choices must be readily available at all times that the premises is open. Menus must be visible and food should be actively promoted. A minimum of three types of food should be available. The range or style of food will be as shown on any menu submitted. Alternatively the range of food should include items such as paninis, pizza, lasagne, toasted or fresh sandwiches, wedges, pies, filled rolls and/or salads.
- e) No alcohol is to be sold if Fez Kebab is not open/operating.
- f) The licensee shall have a reasonable range of low alcohol and non-alcoholic refreshments available for consumption on the premises at all times when alcohol may be sold under this licence
- g) The licensee shall ensure that drinking water will be made readily available to all patrons at each table, free of charge
- h) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons
- i) The whole of the premises is undesignated.
- j) The holder of a Manager's Certificate or a properly appointed manager shall be on duty and on the premises at all times alcohol is sold. If a duty manager is not present then there must be no alcohol sales and a notice displayed advertising the public of this fact
- k) Manager's register (as required by s.232 of the Act) is to be maintained and available onsite



- l) The licensee must ensure the following are displayed:
- (i) A sign to be seen from outside the principle entrance stating the ordinary hours of business during which the premise will be open for the sale of alcohol
  - (ii) A copy of the original licence with all the conditions, just inside the principal entrance so persons entering can read it.
  - (iii) A sign in a prominent place identifying the duty manager.
- m) A sign in a prominent place identifying the duty manager
