### **Grazing contract**

# Water watch - every drop counts

Due to the high water demand across our district, water restrictions have moved to level two and hosing is now restricted to alternate days only.

If you live at an even street number you can hose on even dates (e.g. 24 Bloggs St, can water on February 12, 14, 16, 18 etc), if you live at an odd street number you can hose on uneven dates (e.g. 23 Bloggs St can water on February 13, 15, 17, 19 etc)

We ask people to conserve water wherever possible, to help reduce the possibility of further restrictions and ensure we have water for essential and emergency needs. If you see any excess water use please call us 0800 746 467.

# Restricted fire season now in force

Our district is experiencing very dry conditions and with a long dry summer period predicted we have moved to a restricted fire season. The restricted fire season is now spread across the entire Thames Valley District.

This means fire permits are required for all fires in the open air. Permits can be arranged at Council offices but at this stage it is unlikely that any permits will be issued.

"We are asking the community to avoid lighting any fires and to inform us as soon as possible if they see a fire." says Nicole Nooyen, Communications Officer.

Protect our district and avoid scenes like below this summer. Most rural fires are detected by the general public or propoety owners, if you see smoke or fire dial 111 and ask for Fire.



# Transport and utilities review - summary of submissions now available

Matamata-Piako District Council has prepared a summary of submissions on:

- Plan Change 43 Transportation reviews the transportation section of the District Plan (section 9), and also includes some amendments to the standards in the Development Manual.
- Plan Change 44 Works and Network Utilities reviews the works and network utilities section of the District Plan (section 8).

The summary of submissions may be inspected, and a further submission made, at any Council office or library, or at www.mpdc.govt.nz.

The following persons may make a further submission on the plan change:

- any person representing a relevant aspect of public interest.
- any person who has an interest in the proposed plan change greater than the interest that the general public has,
- Matamata-Piako District Council.

You may make a further submission by sending a written or electronic submission to Matamata-Piako District Council by one of the following methods:

The further submission must be made using Form 6 of Schedule 1 of the Resource Management (Forms, Fees, and Procedure) Regulations 2003 and must

relate to a matter in an original submission to the plan change. Copies of this form are available from the locations listed above.

You must also send a copy of your submission to the original submitter within five working days of lodging your submission with Council.

Further submissions close at 5pm on Wednesday 26 February, 2014.

The process for public participation in the consideration of the plan change under the Resource Management Act 1991 is as follows:

- If a person making a submission asks to be heard in support of his or her submission, a hearing must be held.
- Matamata-Piako District Council must give its decision on the provisions and matters raised in the submissions (including its reasons for accepting or rejecting submissions), give public notice of its decision within two years of notifying the plan change, and serve it on every person who made a submission at the same time.
- Any person who has made a submission has the right to appeal against the decision on the plan change to the Environment Court if, in relation to a provision or matter that is the subject of the appeal, the person referred to the provision or matter in the person's submission on the plan change.

This notice is prepared in accordance with clause 7 of Schedule 1 of the Resource Management Act 1991.
